MINUTES OF THE BOARD OF DIRECTORS THE HOMES, INC. July 15, 2024

The regular monthly meeting of the Board of Directors of The Homes, Inc. was called to order at 5:30 p.m. on June 17, 2024.

Present were: Frank Moss, Charles Sawyer, Jerry Demeyer, Ray Olson and Elaine Hines, Board Members; Elizabeth Bothwell, Manager; Greg Goheen, Attorney; and Karen Brokesh, Transcriber.

Ten stockholders and residents attended the meeting.

It was announced that the work order report for June has been posted.

Minutes of the regular meeting of June 17, 2024 and the executive session had previously been distributed to all board members. Elaine Hines moved to approve the minutes as submitted. Seconded by Jerry Demeyer. Carried unanimously.

Treasurer Olson reported that he has reviewed the financial statement for the month of June 2024 and found it to be in good order. Ray Olson moved to approve the financial report. Seconded by Charles Sawyer. Carried unanimously.

There were no stockholder change requests for manager or board approval.

After being informed that the stock transfers were in order, it was moved by Jerry Demeyer and seconded by Ray Olson that the Corporation waive its option to purchase the shares of stock and approve transfer of same. Carried unanimously. The manager was reminded that all original signed stock certificates must be stored with the credit union if the stockholder has an outstanding loan.

Old Business to be Discussed:

The Unified Government Legal Department submitted a proposed value for the 2022 real estate taxes of around \$180,000. The Homes paid \$280,000.00.

The fire repairs to 123 Viewcrest are almost complete.

Information on potholes to be repaired has been submitted to the Unified Government.

New Business to be Discussed:

Residents with small trees (10-15 feet) in their yards are being sent letters informing them that the tree(s) will be removed. If residents do not want the tree(s) removed, then they will have to sign an agreement acknowledging they will be responsible for the trimming and/or removal of the trees.

Outside inspections have begun and are going well. If needed, residents have been asked to paint their porch railings, door frame, threshold, and/or porch ceilings. The inspections have revealed many porch railings have rusted out at their connections to the cement. Due to the number of repairs this will be an ongoing project for many months.

Updated occupant forms will be sent out at the end of the month.

A stockholder recently passed away and the person they had designated as a transfer on death (TOD) for the stock had previously passed away. Stockholders were asked to have a current TOD on file at the office. Forms are available on The Homes website or at the office.

Volunteers have been found to help with the credit union. However, if anyone is interested in volunteering, they are encouraged to contact the office.

Comments from Directors and Attorney:

Comments from Stockholders:

The stockholder at 127 Viewcrest commented on carbon monoxide detectors and trees near the playground.

The stockholder at 12 Reidcrest had questions about maintenance and work orders.

The stockholder at 120 Viewcrest asked a question about the colors that the buildings are being painted.

The stockholder at 24 Viewcrest commented on the colors the buildings were being painted.

The stockholder at 1 Reidcrest commented on tree trimming, parking issues and wind damage to the building roof.

The stockholder at 12 Summitteest thanked the office staff and manger for all the work they do when stockholders pass away and commented on sunken pavement at 10^{th} and Manorcrest.

The stockholder at 108 Viewcrest commented on abandoned cars in the neighborhood and damage to the retaining wall near her unit.

The stockholder at 86 Manorcrest reported a sidewalk issue and commented on the stump in their yard.

HELPFUL HINTS ABOUT LIVING IN THE HOMES

PLUMBING: DO NOT FLUSH FLUSHABLE WIPES. The pipes in our homes are over 70 years old. They do not have the capacity to wash away any other material. Do not flush baby wipes, feminine hygiene products, diapers, paper towels, Q tips, etc. The sink and tub drains are only for water disposal. Do not force items down the drains. If maintenance finds these items consistently causing a backup in your pipes you may be charged for the repair.

PARKING: The Homes does not have assigned parking. Please be considerate of your neighbors and their parking needs. Try not to park in a spot that is normally used by your neighbor. If you have guest, have them park in the overflow lots. NEVER PARK IN YARDS OR COMMON GROUND. EXPIRED VEHICLE TAGS WILL BE TURNED OVER TO THE SHERIFF'S DEPARTMENT FOR TICKETING AND TOWING.

YARDS & PORCHES: Please take the time to clean up/organize your yard and porch. The size of our porches does not allow for you to keep many items on them before they start to look cluttered and messy. If you do not have a shed an affordable alternative is to store your items in a deck or patio box. They range in cost from \$30 to \$100 and can be purchased on-line or at your local discount store. Items that should not be on your porch: appliances, boxes, buckets, mops, paint containers or any other "non outdoor" items. The office offers free paint for your porch railings.

SPEEDING. The speed limit in The Homes, Inc. is 20 mph. It only takes a few seconds for a distracted child to dart out in the road. Please be aware and safe while driving.

AUTOMOBILE REPAIR. It is against the rules to work on your vehicle in The Homes. If your vehicle needs repair, then you will have to take your vehicle out of the neighborhood or take your vehicle to a mechanic. Unless you are changing a flat tire, you should NEVER put your vehicle on a jack in the Homes.

LITTERING. Think twice about throwing your trash out your car window or into someone's yard. First, it's rude and selfish. Someone will have to pick it up and most of the time it is the maintenance staff. This takes time and money away from other resident's needs. Second, it is against the law. Littering is a Class C violation that is punishable by a fine up to a \$500.00.

KEEP FURNANCE AND WATER HEATER AREAS CLEAN. Having too many clothes, boxes, or general clutter in your utility area can be a fire hazard. Please keep yourself and your neighbors safe and keep your utility areas clean. DO NOT PILE CLOTHES OR OTHER ITEMS ON TOP OF THE WATER HEATER OR FLU AREA.

NOISE. Please be mindful of the level of noise you create. It is our responsibility to keep the sound we make to a reasonable level, so we are not disturbing our neighbors. Sometimes, simply communicating with your neighbors and working out an understanding can resolve this and many other problems.

STICKS AND LIMBS: Place sticks/limbs in 4-foot bundles to the curbside for pickup by maintenance.

MEDICARE AND MEDICAID

Did you know that in Kansas, you can receive both Medicare and Medicaid (KanCare)? If you have limited income and assets and are seeking nursing home care, long-term care, or home health care services, you may be able to enroll in both Medicare and KanCare. Those who qualify for both programs, known as dual eligibles, can potentially receive help for items or services that Medicare does not cover, such as:

- Physical, occupational, or speech therapy
- Hospice Care
- Optometry/eyeglasses
- Dental services/dentures
- Personal care
- Prescription drugs

Not only are these costs potentially covered, but other Medicare Part A and Part B costs may as well. These include:

- Deductibles
- Coinsurances
- Copayments

Extra Help, a program designed to help cover Part D prescription drug costs, is another option available to those who qualify for Medicare and KanCare. Guidelines established by the federal government are used to determine whether an individual is eligible for coverage from KanCare. These include an individual's income and assets being below a certain amount to qualify, but these amounts vary from program to program. To see these guidelines and to find out how to apply for KanCare, you can go to www.kancare.ks.gov/consumers/apply-for-kancare. ELDER FINANCIAL EXPLOITATION

Elder financial exploitation is the illegal or improper use of an older adult's funds, property, or assets. It is the most common form of elder abuse, but only a small fraction of incidents are reported. Losing money or possessions to scams, fraud and exploitation can be especially devastating to older adults who may not be able to earn back what they lost. The perpetrators can be strangers who gain the trust of older adults, but they can also be family members or friends. It is important to know the warning signs.

- Sudden changes in bank accounts or banking practices
- Unusual use of credit cards
- Telephone, water, electricity or other utilities being shut off
- Unpaid bills, liens or foreclosure notices despite sufficient income
- Checks written to "cash" or unauthorized ATM withdrawals
- Turning over finances or transferring assets to others without explanation or consent
- Disappearance of cash, valuable objects or financial statements
- Unexplained changes to wills or other financial documents
- Sudden changes in an elder's mood or demeanor.

However, older adults can fight back by putting a few things in place before financial exploitation happens to them, such as choosing a trusted contact person who can help you protect your money. Work with your bank or credit union to protect older adults from financial exploitation and planning ahead for diminished capacity and illness.
