DRIVEWAY GUIDELINES

- 1. A stockholder change request must be completed.
- 2. A drawing or map showing the layout of the driveway with feet and inches indicated on each side of the driveway, EXAMPLE attached
- 3. A detailed list of the materials that will be used, EXAMPLE
 - -Cement
 - -Wood or plastic forms
 - -What kind of filler will be used
 - -Reinforcing mesh or bars
- 4. All driveways must be 4" thick or more
- 5. The entirety of the driveway can not take up more than 40% of the units property.
- 5. Contact KANSAS811 to have all utilities marked before digging.
- 6. If the work is being done by a contractor, a certificate of liability must be provided to The Homes, Inc.
- 7. If at anytime The Homes, Inc. needs to access plumbing lines underneath the driveway the following are applicable
 - -Whatever the cost is to remove portions of the driveway will be at the expense of the stockholder.
 - -Whatever the cost is to replace portions of the driveway will be at the expense of the stockholder. If this is not done in a timely matter, the driveway will have to be removed.

This document must be signed by the stockholder and if not performing the work themselves, a contractor. By signing this document you agree to follow the guidelines listed.
