Homestead / Safe Senior Property Tax Refund DEADLINE: APRIL 18, 2023

Homestead Rebates are offered to eligible citizens who live in Wyandotte County, Kansas for a portion of their property taxes.

If you were a Kansas resident for all of 2022 and owned and occupied a homestead, you are eligible for a refund of \$700 if your total household income is \$37,750 or less, AND you:

Were born before January 1, 1967; OR

Were totally and permanently disabled or blind for the entire year of 2022; OR Have a dependent child who lived with you the entire year that was born before January 1, 2021 and was under the age of 18 for all of 2022; OR

Are a disabled veteran (50% or more) or the surviving spouse of a disabled veteran who has not remarried, or the surviving spouse of an active duty military personnel who died in the line of duty and not remarried.

As a Kansas resident for all of 2022 who owned AND occupied a homestead, you are eligible for a refund of 75% of your property taxes paid if your total household income including social security is \$22,000 or less, AND you:

Were 65 years or older for all of 2022; Must not have delinquent property taxes in 2022.

Household income is generally all taxable and non-taxable income received by all members of the household. You can complete a Form K-40H or K-40PT electronically or have our Clerk's Office help you complete the required documentation. 

HELPFUL HINTS ABOUT LIVING IN THE HOMES

KEEP FURNACE AND WATER HEATER AREAS CLEAN. Having too many clothes, boxes, or general clutter in your utility area can be a fire hazard. Please keep yourself and your neighbors safe and keep your utility areas clean. DO NOT PILE CLOTHES OR OTHER ITEMS ON TOP OF THE WATER HEATER OR FLU AREA. CHANGE YOUR FURNACE FILTER ONCE A MONTH. FILTERS ARE FREE AT THE OFFICE.

PLUMBING: DO NOT FLUSH FLUSHABLE WIPES. The pipes in our homes are over 70 years old. They do not have the capacity to wash away any other material. Do not flush baby wipes, feminine hygiene products, diapers, paper towels, Q tips, etc. The sink and tub drains are only for water disposal. Do not force items down the drains. If maintenance finds these items consistently causing a back-up in your pipes you may be charged for the repair.

LITTERING. Think twice about throwing your trash out your car window or into someone's yard. First, it's rude and selfish. Someone will have to pick it up and most of the time it is the maintenance staff. This takes time and money away from other resident's needs. Second, it is against the law. Littering is a Class C violation that is punishable by a fine up to a \$2500.00. If you are witnessed littering the police will be called and you will be charged, by The Homes, for the time it takes to pick it up and dispose of it.

PARKING: The Homes does not have assigned parking. Please be considerate of your neighbors and their parking needs. Try not to park in a spot that is normally used by your neighbor. If you have guest, have them park in the overflow lots. If you have vehicles that you do not drive, park it in an overflow lot. **NEVER PARK IN YARDS OR COMMON GROUND.**

NOISE. Please be mindful of the level of noise you create. It is our responsibility to keep the sound we make to a reasonable level, so we are not disturbing our neighbors. Sometimes, simply communicating with your neighbors and working out an understanding can resolve this and many other problems.

YARDS & PORCHES: Please take the time to clean up/organize your yard and porch. The size of our porches does not allow for you to keep many items on them before they start to look cluttered and messy. If you do not have a shed an affordable idea to store your items in are deck and patio boxes. They range in cost from \$30 to \$100 and can be purchased on-line or at your local discount store. Items that should not be on your porch: appliances, boxes, buckets, mops, paint containers or any other "non outdoor" items. The office offers free paint for the porches.

SPEEDING. The speed limit in The Homes, Inc. is 20 mph. It only takes a few seconds for a distracted child to dart out in the road. Please be aware and safe while driving.

AUTOMOBILE REPAIR. It is against the rules to work on your vehicle in The Homes. If your vehicle needs repair, then you will have to go out of the neighborhood or take your vehicle to a mechanic. Unless you are changing a flat tire you should never put your vehicle on a jack in the Homes.

TRASH. Do not put your trash in your neighbor's trash bins.

5. How long can food stay frozen if the power goes out?

COLD-SEASON POWER OUTAGES

Most cold-season power failures happen when winter storms bring freezing rain, sleet, and high winds, damaging power lines and equipment. Without a steady supply of heat, not only are you impacted, but your home can suffer from dampness, damaging walls, floors and plumbing.

During a winter power outage

- -Before you take action, make sure the outage goes beyond your home. Check your breakers or fuses and the power lines to your house. If the lines are damaged or down, stay back and call your electric company.
- -Stay warm... On top of dressing in layers and huddling under extra blankets, hang your darker ones on the windows to draw in heat. Keep doors and windows closed, and use towels to block drafts around them. If necessary, move to your basement, which may be more insulated by the ground.
- -...but keep your food cold. Food can stay frozen 24 to 36 hours if the refrigerator/freezer door stays closed. Add snow and ice from outside if it starts to thaw. Always have a bag of ice cubes in the freezer in case you have to evacuate or when you're out of town; if the cubes melt and refreeze while you're away, the food in the freezer will probably be spoiled.
- -Listen for updates. Listen to the news on a battery-powered or hand-cranked device. If you're using a cellphone, choose texting over calling to keep phone lines free, or use your landline.
- -Save 911 for emergencies.
- -Prevent additional damage. Unplug appliances and electronics to avoid a surge when the power comes back on; leave one lamp on so you know when the power comes back. If you have electric heat, keep all taps on a slow drip to prevent pipes from freezing and bursting.

Have a survival kit ready before the power goes out

Water: one gallon per person, per day (3-day supply for evacuation, 2-week supply for home)

Food: non-perishable, easy-to-prepare items (3-day supply for evacuation, 2-week supply for home). Flashlight

Battery-powered or hand-crank radio (NOAA Weather Radio, if possible)

Extra batteries

Deluxe family first aid kit

Medications (7-day supply) and medical items

Multi-purpose tool

Sanitation and personal hygiene items

Copies of personal documents (medication list and pertinent medical information, proof of address,

deed/lease to home, passports, birth certificates, insurance policies)

Cell phone with chargers and battery banks

Family and emergency contact information

Extra cash

Emergency blanket

Map(s) of the area

Consider the needs of all family members and add supplies to your kit:

Medical supplies (hearing aids with extra batteries, glasses, contact lenses, syringes, etc), Baby supplies (bottles, formula, baby food, diapers), Games and activities for children, Pet supplies (collar, leash, ID, food, carrier, bowl), Two-way radios, Extra set of car keys and house keys, Manual can opener, Whistle, N95 or surgical masks, Matches, Rain gear, Towels, Work gloves, Tools/supplies for securing your home, Extra clothing, hat and sturdy shoes, Plastic sheeting, Duct

tape, Scissors, Household liquid bleach, Entertainment items, Blankets or sleeping bags

Senior Citizens' Utility and Sales Tax Rebate Program DEADLINE: MARCH 31, 2023

Sales Tax and Utility rebates are offered to eligible citizens who live in Kansas City, Kansas for a portion of their BPU, Gas or AT&T utility bills and/or have paid sales tax.

To qualify for the refund, ALL THREE of the following must apply:

Resident of Kansas City, KS;

65 years of age or older during the entire 2022 calendar year;

Gross household income does not exceed \$25,000.

To apply you'll need the following information:

Name

Last four digits of your social security number

Mailing address

Date of birth

Telephone number

Copy of your 2022 gas, BPU, and phone bills

Proof of 2022 income (social security, pensions, disability, W2 tax reports, interest, etc.),

including your spouse's income.

Submit your information today via mail, fax, or in-person at 701 N. 7th Street, Room 323, Kansas City, Kansas 66101. All applications must be received or postmarked by March 31, 2023.

You may also make an appointment at one of our various sites throughout the County by calling our 3-1-1 line. Transportation will be provided at no charge to the applicant.
