The area of the park that was chosen to add overflow parking (119-139 Viewcrest) will not be turned into parking because it is too expensive. The cost would have been between \$20,000 and \$25,000. Manager will continue to look at other areas where parking may be expanded.

New Business to be Discussed:

Additional video surveillance cameras for security in the neighborhood was discussed. Beatrice Arce moved to spend between \$5,500 and \$6,000 to purchase and install additional video cameras in the community. Seconded by Frank Moss. Carried unanimously.

TORNADO SAFETY

Living in the Kansas City area, we know all too well about the dangers of tornadoes. Despite living in the Midwest, where tornadoes frequently threaten the spring and early summer weather, relatively few residents actually have a **home tornado plan** or **disaster supply kit** in place. It's important to **stay tuned** for storm warnings and know the difference between a **tornado WATCH** and **tornado WARNING**.

Prepare a Home Tornado Plan

Pick a place where family members could gather if a tornado is headed your way. It could be your basement or, if there is no basement, a center hallway, bathroom or closet on the lowest floor. Keep this place uncluttered.

Assemble a Disaster Supplies Kit Containing:

First Aid kit and essential medications.

Canned food and can opener.

At least three gallons of water per person.

Protective clothing, bedding or sleeping bags.

Battery-powered radio, flashlight and extra batteries.

Special items for infant, elderly or disabled family members.

Stay Tuned for Storm Warnings

Listen to your local radio and TV stations for updated storm information.

Know what a tornado WATCH and WARNING means:

A tornado WATCH means a tornado is possible in your area.

A tornado WARNING means a tornado has been sighted and may be headed for your area.

Go to safety immediately.

When a Tornado WATCH Is Issued...

Listen to local radio and TV stations for further updates.

Be alert to changing weather conditions. Blowing debris or the sound of an approaching tornado may alert you. Many people say it sounds like a freight train.

When a Tornado WARNING Is Issued...

If you are inside, go to the safe place you picked to protect yourself from glass and other flying objects. The tornado may be approaching your area.

If you are outside, hurry to the basement of a nearby sturdy building or lie flat in a ditch or low-lying area.

If you are in a car or mobile home, get out immediately and head for safety (as above).

After the Tornado Passes...

Watch out for fallen power lines and stay out of the damaged area.

Listen to the radio for information and instructions.

Use a flashlight to inspect your home for damage.

Do not use candles at any time.

STORY OF FOOD WASTE

According to the EPA, we waste 133 *billion* pounds of food in the United States every year. When food goes to the landfill it breaks down and creates methane, one of the most potent greenhouse gases that effects climate change. About half of that 133 billion pounds is wasted by house-holds. Much of the food that goes to landfills can and should be redirected to other sources that can still make use of it and keep it from going to waste.

The EPA's Food Recovery Hierarchy includes six recovery methods from most to least preferred:

- Source Reduction
- Feed Hungry People
- Feed Animals
- Industrial Uses
- Composting
- Land Incineration

While reducing the amount of extra food produced to begin with is the most desirable way of reducing waste, feeding people is a close second. 18% of Wyandotte County is food insecure, and 65% of residents are eligible for benefits like SNAP and free school meals, so any food that we save can go a long way towards providing meals for those most in need right here in our community.

However, not all food that gets thrown away is suitable for human consumption. Most food scraps make great ani-mal feed, and reduce the cost of care for farmers and other animal keepers. At home, you can use some of your scraps to feed family pets or livestock (hens love fruit and vegetable scraps!).

Another way to reuse food that would otherwise be thrown away is for industrial purposes. Many foods can be turned into valuable oils or biofuel that are greener alternatives to coal and natural gas, and are a good way to recover some of the energy that went into producing that food.

Composting is another way to use the food that people or animals cannot eat. Composted food makes for a wonderful soil amendment in any gardens because all the nutrients from the food scraps get returned to the earth and used to grow new food. It can also be a fun way to teach friends, family, and children about the growing cycle and where our food comes from. Composting is also one of the easiest ways to keep food from going to the landfill as an individual or family, and there is a composting method out there for everyone.

Food waste can seem like a problem that doesn't affect you, but if you spend a week keeping track of all the food you throw away, it adds up more quickly than you think. The great thing about food waste is that you can very easily reduce your impact through making small changes to your lifestyle, like shopping from a list and planning your meals. Even making just one change can greatly reduce the amount of food waste you send to the landfill, especially if you encourage others to join in. Because if we all work together, we can make a healthier environment for our community

Household Hazardous Waste Collection days for Wyandotte County residents includes the following Saturdays: May 18, June 15, July 20, August 17, September 21, and October 19, 2019. The site will be open from 8:30 a.m. to 1:00 p.m. on those Saturdays.

Wyandotte County residents need to take their household hazardous products to 2443 South 88th Street in Kansas City, Kansas. (South on 88th Street from K-32) or (East of I-435 using Woodend exit near Kaw River) The HHW Days are not for business or nonprofit groups.

When bringing items to the collection site please label or identify all items. Items accepted include automotive products, home improvement products, household items, as well as lawn and garden products.

Automotive products accepted include auto batteries, brake fluid, carburetor cleaner, degreasers, gasoline & fuels, and used motor oil. In addition, residents can bring 10 car and/or pickup tires if the rims are removed from the tires.

Home improvement products accepted include concrete cleaner, driveway sealer, furniture stripper, glue with solvents, latex & oil based paints, paint thinner, putty, grout, calk & spackle, roofing tar, stain varnish & lacquer, turpentine, water-based glues, and wood preservatives.

Household items include aerosol products, drain & oven cleaners, mothballs, nail polish remover, polishes with solvents, spot remover, and propane cylinders.

Lawn and garden products include fertilizer with weed killer, herbicides, insecticides, pesticides, and rodent bait.

ELPFUL HINTS ABOUT LIVING IN THE HOMES

PLUMBING: DO NOT FLUSH FLUSHABLE WIPES. The pipes in our homes are over 70 years old. They do not have the capacity to wash away any other material. Do not flush baby wipes, feminine hygiene products, diapers, paper towels, Q tips, etc. The sink and tub drains are only for water disposal. Do not force items down the drains. If maintenance finds these items consistently causing a backup in your pipes you may be charged for the repair.

PARKING: The Homes does not have assigned parking. Please be considerate of your neighbors and their parking needs. Try not to park in a spot that is normally used by your neighbor. If you have guest, have them park in the overflow lots. **NEVER PARK IN YARDS OR COMMON GROUND.**

YARDS & PORCHES: Please take the time to clean up/organize your yard and porch. The size of our porches do not allow for you to keep many items on them before they start to look cluttered and messy. If you do not have a shed an affordable alternative is to store your items in a deck or patio box. They range in cost from \$30 to \$100 and can be purchased on-line or at your local discount store. Items that should not be on your porch: appliances, boxes, buckets, mops, paint containers or any other "non outdoor" items. The office offers free paint for your porch railings.

SPEEDING. The speed limit in The Homes, Inc. is 20 mph. It only takes a few seconds for a distracted child to dart out in the road. Please be aware and safe while driving.

AUTOMOBILE REPAIR. It is against the rules to work on your vehicle in The Homes. If your vehicle needs repair, then you will have to take your vehicle out of the neighborhood or take your vehicle to a mechanic. Unless you are changing a flat tire, you should **NEVER** put your vehicle on a jack in the Homes.

LITTERING. Think twice about throwing your trash out your car window or into someone's yard. First, it's rude and selfish. Someone will have to pick it up and most of the time it is the maintenance staff. This takes time and money away from other resident's needs. Second, it is against the law. Littering is a Class C violation that is punishable by a fine up to a \$500.00.

KEEP FURNACE AND WATER HEATER AREAS CLEAN. Having too many clothes, boxes, or general clutter in your utility area can be a fire hazard. Please keep yourself and your neighbors safe and keep your utility areas clean. **DO NOT PILE CLOTHES OR OTHER ITEMS ON TOP OF THE WATER HEATER OR FLU AREA.**

NOISE. Please be mindful of the level of noise you create. It is our responsibility to keep the sound we make to a reasonable level, so we are not disturbing our neighbors. Sometimes, simply communicating with your neighbors and working out an understanding can resolve this and many other problems.

STICKS AND LIMBS: Place sticks/limbs in 4 foot bundles to the curbside for pickup by maintenance.
